Re: Proposal under the Bankruptcy and Insolvency Act

We are writing to advise that on October 27, 2017, Planit Builders Ltd. (the "Company" or "Planit") filed a *Notice of Intention to Make a Proposal* pursuant to the *Bankruptcy and Insolvency Act* (the "Act"). Hardie & Kelly Inc. was appointed as trustee under the proposal (the "Trustee"). Enclosed please find the following in connection with the proceedings:

- Certificate of Filing of a Notice of Intention to Make a Proposal issued by the Office of the Superintendent of Bankruptcy;
- Notice of Intention to Make a Proposal and listing of creditors greater than \$250; and
- Trustee's Consent.

S. 69(1) of the Act provides the Company with certain relief including the imposition of an initial 30-day *Stay of Proceedings* against the Company and its assets. Claims against the Company for payment of goods and services supplied to Planit prior to October 27, 2017 are suspended and creditors are prohibited from continuing or commencing any actions or exercising any rights against the Company except with leave of the Court of Queen's Bench of Alberta.

You are not required to file a proof of claim at this time. Further information will be distributed to you in due course. Creditors are encouraged to regularly check the Trustee's website at <http://relieffromdebt.ca/planit-builders-inc> (the "Website") for updates as to the status of the proceedings as additional materials will be posted to the Website from time to time.




