UPON the application of Hardie & Kelly Inc. ("HKI"), in its capacity as the court-appointed receiver and manager (the "Receiver") of the debtor, Quattro Exploration and Production Ltd. ("Quattro"), and not in its personal capacity; AND UPON having read the Ninth Report of the Receiver dated October 12, 2018 (the "Final Report"), the Receiver's prior reports, and other pleadings, affidavits and documents filed in these proceedings, including the receivership order (the "Receivership Order") granted on February 2, 2017 (the "Receivership Date"); AND UPON noting that HKI was appointed by the Court as the monitor of the Debtor (the "Monitor"), pursuant to an Initial Order under the *Companies' Creditors Arrangement Act*, RSC 1985, c C-36 (the "CCAA") granted on September 8, 2016 (the "Initial Order"); AND UPON hearing from counsel for the Receiver and counsel for any other interested parties appearing at the hearing of this Application:

**IT IS HEREBY ORDERED AND DECLARED THAT:**

1. The time for service of this Application is hereby declared to be good and sufficient, this hearing is properly returnable before this Honourable Court today, and any further service of this Application is hereby dispensed with.
2. The Application of Dorothea Holdings Ltd. and 1348321 Alberta Ltd. (together, the "Claimants") filed in these proceedings on August 7, 2017 be and is hereby dismissed.
3. The Statement of Claim of the Claimants filed in Action No. 1801-11001 on August 7, 2018 be and is hereby dismissed.
4. The Receiver shall have the costs of this Application in the amount of \$ 1250.00 ✓
