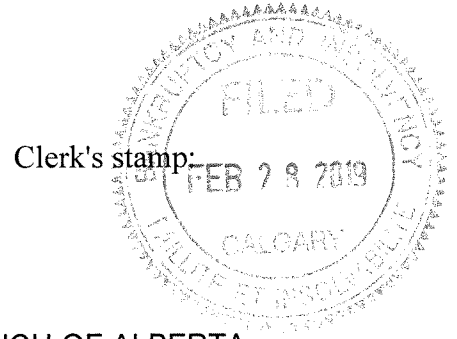

UPON the application (the "**Application**") of PDW Holdings, Inc. ("**PDW**");

AND UPON having read the Affidavit of Peter D. Weber sworn on November 21, 2018, the Secretarial Affidavit of Lindsay Farr sworn on November 23, 2018, and the Secretarial Affidavit of Elisabeth Wade sworn on February 19, 2019;

AND UPON being satisfied that WhoZaGood Inc. ("**WZG**") and all interested and affected parties have been served with notice of the within Application;

AND UPON being satisfied that WZG has committed an act of bankruptcy in the six months preceding the filing of the within Application;

AND UPON being satisfied there are grounds to declare the proposal made by WZG (the "**Proposal**") in Court File Number 25-2452031 as deemed refused by WZG's creditors;

AND UPON noting the consent of Hardie & Kelly Inc. ("**H&K**") to be appointed as trustee of the bankrupt estate of WZG in the within proceedings and being satisfied that H&K is a person qualified to act;

AND UPON hearing from counsel for PDW, counsel for H&K, and any other interested party appearing at the Application;

IT IS HEREBY ORDERED AND DECLARED THAT:

1. Service of notice of the Application and materials filed in support thereof is hereby validated and deemed good and sufficient.
2. WZG is hereby adjudged bankrupt by virtue of this Order being made on this date.
3. The Proposal in Court File Number 25-2452031 is hereby deemed refused by WZG's creditors.
4. H&K is appointed as trustee of the bankrupt estate of WZG (the "**Trustee**") without the requirement to give security under the *Bankruptcy and Insolvency Act*, RSC 1985, c B-3, as amended (the "**BIA**") and the Trustee is authorized to take all necessary steps to take possession of the deeds, books, records, and documents and all property of WZG and to administer the bankrupt estate of WZG.
5. The Trustee shall be given full access to the deeds, books, records, and documents of WZG, including, but not limited to, all documents located at 13911 Deer Ridge Dr. SE, Calgary, Alberta (the "**Subject Premises**").

6. WZG and/or any occupants of the Subject Premises must grant access to and assist the Trustee in locating and obtaining all records and property of WZG, including through the access and copying of any hard drives, servers, or other electronic repository media of WZG.
7. WZG, its agents, employees, representatives, servants, assigns, or any other party acting on WZG's behalf are prohibited from removing any of WZG's property from the Subject Premises without the Trustee's consent and shall fully cooperate with the Trustee with locating any property of WZG.
8. Subject to paragraph 10 of this Order, the Trustee shall not be required to provide notice to, or obtain consent from, any registered owner, landlord, tenant, or person residing in or occupying the Subject Premises prior to entering onto and inside the Subject Premises for the purpose of locating, identifying, and taking possession and control of the property of WZG. The Subject Premises includes any automobiles, storage facilities, or other premises upon which computing devices, discs, or electronic storage devices of WZG are located.
9. Subject to paragraph 10 of this Order, the Trustee may take whatever steps are necessary to gain access to any locked or secured cabinet, container, safe, safety deposit box, door, security system, room, suite, or computer located in, upon, or about the Subject Premises, for the purpose of locating, identifying, and taking possession and control of WZG's property.
10. Any search of the Subject Premises which is carried out by or on behalf of the Trustee for the purpose of locating, identifying, and taking possession and control of WZG's property:
 - (a) shall take place between the hours of 9:00 a.m. and 5:00 p.m. on any day of the week other than Sunday;
 - (b) if not completed prior to 5:00 p.m. on any particular day, may be completed between 9:00 a.m. and 5:00 p.m. on a subsequent day (other than a Sunday);
and

- (c) shall involve no more than three persons carrying out such a search, including contractors or agents whose assistance, services, or expertise the Trustee may require, such as legal counsel, locksmiths, bailiffs, computer technicians, and peace officers.
11. In the event of any claim of ownership by any third party over any property of WZG, that claimed property shall be identified, segregated, and kept in the possession or control of the Trustee until such time as the ownership of said property can be determined by either agreement between the Trustee and the claimant or by further Order of the Court.
12. The provisions of this Order shall not in any way derogate from the rights, powers, duties, and authority given to the Trustee under the BIA or the *Bankruptcy and Insolvency General Rules*, CRC c 368.
13. The costs of and incidental to the Application and this Order shall be paid to PDW out of the assets of WZG's estate after taxation of the accounts.
