Re: Proceedings under BWI's Companies' Creditors Arrangement Act (the "CCAA")

By Order of the Honourable Justice S.J. Lovecchio granted June 15, 2009 in the Court of Queen's Bench of Alberta Action No. 0901-03296 ("Claims Order"), Hardie & Kelly Inc. in its capacity as Monitor of BWI (the "Monitor") has been authorized to conduct a claims procedure for BWI. A copy of the Claims Order can be found on the Monitor's website at www.insolvency.net under the "Current Engagements" link or by contacting the Monitor directly.

Any creditor (i) having a claim against BWI **arising on or before March 4, 2009** of any nature whatsoever, including an unsecured, secured, contingent or unliquidated claim, (a "Pre-Filing Claim") and/or (ii) having a claim against BWI arising after March 4, 2009 as a result of the disclaimer or repudiation, after March 4, 2009, of any contract, lease, employment agreement or other arrangement or agreement of any nature whatsoever, whether oral or written, and any amending agreement related thereto (a "Subsequent Claim") is required to file with the Monitor a *Notice of Claim* in order to participate in any voting or distributions associated with BWI's CCAA proceedings.

The deadline for filing claims with the Monitor is as follows:

- Pre-Filing Claims - 5:00 p.m. Mountain Time on August 25, 2009.
- Subsequent Claims - the later of i) 5:00 p.m. Mountain Time on August 25, 2009, and ii) 5:00 p.m. Mountain Time on the day which is 30 days after the date on which the disclaimer or repudiation giving rise to the Subsequent Claim arose.


