1. Clinitrust has at some time during the six months next preceding the filing of this Petition carried on business at Suite 108, Advanced Technology Centre, 9650 – 20 Avenue, Edmonton, Alberta, T6N 1G1 within the jurisdiction of this Court.
2. As of October 30, 2009, Clinitrust was justly and truly indebted to 888 in the following amounts, exclusive of recoverable professional fees and expenses:

Principal	\$800,000.00
Interest	<u>\$162,055.53</u>
Total	\$962,055.53

3. 888 is a creditor of Clinitrust pursuant to three debentures dated August 1, 2008, November 1, 2008 and February 1, 2009.
4. Clinitrust within the six months next preceding the date of the filing of this Petition, has committed the following act of bankruptcy, namely:

(a) Ceased to meet its liabilities generally as they became due and in particular, failed to pay the outstanding indebtedness owed to the Petitioner.


