3. Circumstances exist that make the Order sought appropriate.



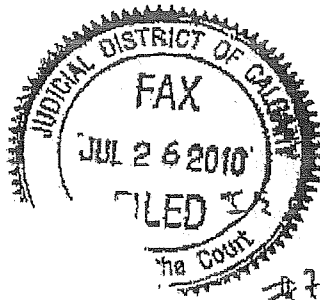
