SECOND REPORT OF RECEIVER

Hardie & Kelly Inc. was appointed as Receiver (the "Receiver") of John Francis Quinn pursuant to an Order of the Court of Queen's Bench of Alberta (the "Court") dated April 23, 2007. The purpose of this report is to advise the Court of the activities of the Receiver since the date of our first report (the "First Report") of August 9, 2007. This report addresses the following:

Introduction and Background

John Francis Quinn was 64 years old at the time of the Receiver's appointment in 2007. He is divorced and has one surviving child, his daughter Dawn T. Quinn who lives in Las Vegas, Nevada. In November 2006, Mr. Quinn suffered a major heart attack in or near Bellingham, Washington which caused significant brain damage. Mr. Quinn was moved to the Dr. Vernon Fanning Centre which is a long-term care facility in Calgary.

Because of Mr. Quinn's limited capacity an application was made pursuant to the Dependent Adults Act to have Mr. Michael Cone appointed Trustee to manage Mr. Quinn's financial affairs. When it became apparent that Mr. Quinn's liquid assets were insufficient to meet his obligations, and with creditors pressing, an application was made by Mr. Cone with the consent of Mr. Quinn's daughter to have a receiver appointed. Mr. Cone also obtained the permission of the court to assign Mr. Quinn's company, Kelly's Cargo Inc. into bankruptcy. Hardie & Kelly Inc. was appointed Trustee.

Calgary Residence

Mr. Quinn's most significant asset in Calgary was his former residence, located at 803 – 104 Avenue S.W. In accordance with the recommendation in our First Report, and the order of this Honorable Court of August 22, 2007 the property was sold for \$329,900.00. After paying the mortgage balance, real estate commissions, and the \$40,000.00 principal residence exemption to the Court Appointed Trustee of Mr. Quinn, the estate realized a net recovery of \$61,055.09.

Furniture and Personal Effects

Further to our recommendation in our First Report, we were unable to find any family members that were prepared to accept and deal with any of the household furniture and effects. Consequently, the items were turned over to All Appraisals to be liquidated. As a result of the liquidation of these items, the estate had a net recovery of \$1,129.88.

Personal items identified in our First Report were not the subject of the liquidation noted above and continued to be stored by the receiver in the hope that a family member would come forward and take responsibility for the items. The items were eventually turned over to Mr. Quinn's sister, Susan Macadam, when she became his guardian.

Kelly's Cargo Inc.

Mr. Quinn's other significant local asset was his interest in Kelly's Cargo Inc. With Mr. Quinn's illness the company had been shut down by Mr. Cone and eventually placed into bankruptcy. Hardie and Kelly Inc. were appointed as Trustee.

While Mr. Quinn was the sole shareholder of the corporation he was also one of the largest creditors with a proven claim in the bankruptcy of \$121,251.00. Total claims filed in the bankruptcy were approximately \$155,000.00. As the Trustee had realized in excess of \$82,000.00 in the bankruptcy Mr. Quinn's Receivership Estate received a dividend of \$50,021.99.

Estate Interest

Mr. Quinn also had an interest in the estate of his late mother Ms. Alice Quinn. Immediately upon our appointment we engaged counsel in the United States and contacted the executrix of Mrs. Quinn's estate, Mr. Quinn's sister Marialice Mulhern. We also commenced a derivative action in the US Bankruptcy Court to have the Receivership Order recognized in that jurisdiction.

Unfortunately, our dealings with Mr. Quinn's assets in the United States, and in particular settling the Estate of his late mother became quite litigious. The Executrix and her counsel were not prepared to recognize Mr. Quinn's entitlement to his inheritance or to the authority of the Receiver. As a result, numerous court applications were required in the US Bankruptcy Court. This resulted in significant delays in dealing with the property at a time when property values were declining. Eventually a settlement was negotiated and sanctioned by the US court. The property was finally sold in late 2009 after approximately a year and one half on the market. As a result of the liquidation of the property the Estate realized a net recovery of \$176,148.61.

Creditors

In accordance with the claims procedure ("Claims Process") authorized by the Order of this Honorable Court of August 22, 2007 (the "Claims Order") the Receiver notified all known creditors of Mr. Quinn and requested that they file a claim with the Receiver in support of the amount owing. The Receiver published advertisements in the Calgary Herald and the Bellingham Herald as well as posting the Claims Process on the Receiver's web-site. As a result of the Claims Process the Receiver has received thirteen claims totaling \$257,689.40. A listing of the Claims

filed with the Receiver is attached as Appendix A to this report. US dollar claims were converted to Canadian dollars at 1.0536 as authorized in the Claims Order.

Receiver's Statement of Receipts and Disbursements and proposed Final Distribution

Attached as Appendix B to this report is the Receiver's Final Statement of Receipts and Disbursements. As is evidenced therein, the Receiver realized \$290,815.96 from the liquidation of Mr. Quinn's assets. Expenses total \$118,371.08 leaving a balance available for distribution to creditors of \$172,444.88.

Attached as Appendix C to this report is the Receiver's proposed final distribution. On the basis of the claims filed pursuant to the Claims Order, creditors will receive a recovery of 66.92% of their claims.

Summary and Recommendations

As all realizations with respect to this estate are now complete, the Receiver recommends and requests that this Honorable Court approve the Receiver's Final statement of Receipts and Disbursements authorize the distribution of the remaining funds in accordance with the schedule in Appendix C and discharge the Receiver upon completion of the distribution.
