## INSTRUCTIONS FOR COMPLETING PROOF OF CLAIM

**A properly completed and supported Proof of Claim form must be submitted to the Trustee in order to have a voice in the affairs of the bankrupt and in order to be eligible for and potential dividend distributions.**

**Please follow these instructions, carefully:**

- Heading**
- a) The name of the bankrupt has been supplied
  - b) Provide the complete name and address, including postal code, where all notices or correspondence regarding your claim are to be forwarded.
  - c) Provide an account number, if applicable.
- Clause 1** The declaration must be completed by an individual not a corporation. If you are acting for a corporation or other person, you must state the capacity in which you are acting, such as, "Credit Manager", "Treasurer", "Authorized agent", etc.
- Clause 2** No response is needed.
- Clause 3**
- a) The date of the bankruptcy has been supplied
  - b) Provide the amount of your claim in Canadian Funds. The amount claimed for debt owing should be calculated to the DATE OF BANKRUPTCY ONLY.
  - c) A Statement of Account must be attached in support of the amount claimed.
    - i) Ensure that the final balance on your Statement of Account agrees to the amount claimed on the Proof of Claim.
    - ii) The Statement of Account must specify each voucher/invoice and/or other evidence in support of the claim, together with the date of each charge and the amount thereof. A schedule which indicates only the BALANCE OF ACCOUNT is NOT sufficient.
    - iii) The Statement of Account must be clearly marked "Exhibit A" and be attached to the Proof of Claim form submitted. If this "Exhibit A" is not attached, your Proof of Claim will be returned.
    - iv) The Statement of Account must also include the last three months transactions, including contra items, if any.
    - v) If a statement is not available an affidavit swearing as to authenticity and amount of the debt may not be used.
- Clause 4** Choose the appropriate section (a), (b), or (c) which properly applies to the status of your claim and circle the corresponding letter.
- a) Applies if you are a creditor without any security
  - b) Applies if you are a creditor with a statutory or contractual claim against some specific asset of the bankrupt. Ensure you record the value of your security and attach copies of your security, documents and evidence of registration.
  - c) Applies if you are a farmer, fisherman or aquaculturist and claiming for unpaid accounts pursuant to subsection 81.2(1) of the Bankruptcy and Insolvency Act. Please attach copies of your documents and give details in the space provided.
- Clause 5** Circle the appropriate wording to indicate whether the creditor is related or not.
- Clause 6** Provide any details only if payment and contra items have not been indicated on "Exhibit A" as referred to in Clause 2 above. If you are related to the bankrupt, the schedule must include transactions for a 12 month period.
- Closing** Ensure that the form is dated, witnessed and signed in the appropriate place. You must also print your name and state your position.
