Upon completion of all distributions contemplated in the Second Report of Receiver, the Receiver is hereby absolutely discharged as Receiver and Manager of the property, assets and undertaking of John Francis Quinn, and the Receiver shall be relieved from any further obligations under or pursuant to the Receivership Order granted herein by Justice P.A.
